

Wardens Peer Interaction Program

The Correctional Management Institute of Texas (CMIT) would like to thank you for your interest in participating in the *Wardens Peer Interaction Program*. This program is hosted by CMIT and the North American Association of Wardens & Superintendents (NAAWS). The next program will be held October 1-5, 2018, at the George J. Beto Criminal Justice Center, located on the campus of Sam Houston State University in Huntsville, Texas.

This program is designed for Wardens and Superintendents, including Deputy and/or Assistant Wardens and Superintendents. It provides an excellent opportunity for participants to interact with their peers to discuss current management and direction for prison/jail operations and programs, as well as time to explore best practices and prepare strategies for handling critical correctional challenges. To aide in the facilitation of the program, participants will be asked to present a topic of critical concern or best practice within their agency or facility. Each presentation will be followed by a discussion period for all attendees to actively participate in.

We ask that selected participants schedule travel for arrival to Huntsville, Texas by 4:30 p.m. on Monday, October 1, 2018. Transportation will be provided for those who fly into George Bush Intercontinental Airport, in Houston, Texas by 2:00 p.m. on October 1, 2018. Participants are asked to prepare a 15 to 20-minute presentation (in conjunction with another attendee from the same agency, if applicable) to present to the group for discussion. Participants are also encouraged to provide a memento to present to each of the participants and facilitators.

The program fee covers all training materials, lunches and dinners (breakfast is included with your stay at the University Hotel) and transportation from and to the George Bush Intercontinental Airport.

Only 35 participants will be accepted and agencies are encouraged to send participants in teams of two. Selected participants will be contacted by our office and provided with additional information regarding the program. Please complete the below application, in its entirety, and submit itto:
